

General Terms and Conditions for Participants, Exhibitors and/or Sponsors at the Update on Neuro-Anesthesia & Neuro-Intensive Care Interdisciplinary neuroscience (Euro Neuro)

The Update on Neuro-Anesthesia & Neuro-Intensive Care Interdisciplinary neuroscience (Euro Neuro) is organized by Promotion des Soins Intensifs (a non-profit association) with academic support from the Departments of Intensive Care and Emergency Medicine of Erasme University Hospital, Université Libre de Bruxelles and the Belgian Society of Intensive Care (SIZ).

I/ Participant

These General Terms and Conditions apply to each participant registered for the Update on Neuro-Anesthesia & Neuro-Intensive Care Interdisciplinary neuroscience, **7- 9 November 2018** in Brussels, Belgium. **By registering, you accept all terms and conditions contained herein.**

All registrations must be made online via our website www.euroneuro2018.org.

Deadlines for registration fees

Early bird registration: until (and including) **March 31, 2018**

2nd price period: from **April 1 –November 6, 2018** (inclusive)

The applicable fee will be calculated according to the date on which payment is received, not the date on which the registration form is completed. Should a deadline be missed, the next applicable fee will be charged automatically. Registration is only confirmed after receipt of payment in full.

Proof of status

For doctor ESICM members, the membership code must be provided during the registration process in order to benefit from the reduced fee.

Doctors from countries with low and lower middle gross national incomes (as defined by the World Bank Atlas method 2017 see list [here](#)) benefit from reduced registration rates - the same as those of non-doctors. This rate will be applied automatically when relevant and proof of residence/employment in the country in question must be provided.

Non-doctor participants (students, nurses, physiotherapists, and other allied healthcare professionals) must submit proof of status (e.g. business card, official letter from Head of Department, etc.) to the Euro Neuro Registration Department during the registration process.

Entitlements

The registration fee includes entrance to the full scientific program, a congress bag.

Sponsors' Mailing Lists

Participants who do not want their name included in lists provided to the industry sponsors must tick the relevant box during the registration process.

Your Euro Neuro badge will have a barcode/QR code, which can be scanned, on request, by industry representatives to enable rapid transfer of your contact details. Accepting to have your badge scanned implies that you agree to have your data transferred.

Please note, requests for refunds of registration fees if a visa is refused will only be considered if an official document from the embassy is sent to the Euro Neuro secretariat showing that the visa was applied for in time and confirming that it could not be granted.
